CODE OF CONDUCT

- Girls admitted to Sardar Patel College in any course in junior and senior faculty will be admitted in the hostel.
- 2. An initial deposit of Rs. 3050 has to be deposited for admission to the hostel.
- The rent will be Rs. 1500 per month till the month of April (including Diwali vacations) which has to be deposited by 10th of every month. The first installment has to be paid at the time of admission.
- 4. Mess charges will be as per the agreement of contractor.
- 5. If you want to leave the hostel during October session you will have to pay full year's rent if you leave the hostel in the first semester after the admission is confirmed, you will have to pay 3 month's additional rent.
- 6. If you stay in the hostel during summer vacation, you have to pay it's rent.
- Additional electricity charges will be divided among the girls in the hostel and will be paid separately (it will know included not included in the hostel rent)
- 8. Cooler, Computer, Press, TV and other electrical appliances are not allowed in hostel room deposit will be fully forfeited if used.
- Girls who use mobile phones should write their mobile number on the form, at the time of admission. In case of change of mobile number, it should be informed to the Warden.
- 10. Prior permission will be required while leaving the hostel.
- 11. The hostelites are responsible to safeguard the materials of gymnasium, newspapers, periodicals, sports equipments, water purifiers, coolers, telephone, computers, T.V. or any other property of the hostel.

COLLECTIVE RESPONSIBILITIES

- The light should be kept on till studying at night and avoid the unnecessary use of electricity.
- It shall be the collective and individual responsibility of the girls to maintain the cleanliness of the hostel and their own room as well as the toilets and mess.
- 3. Do not behave in away that disturbs other girls, do not use radio, tape, TV and mobile unnecessarily.
- 4. It will be compulsory for all the girls to attend Independence Day, Republic Day and Maharashtra Din.
- 5. General damages to the hostel property will be the collective responsibility of all the hostelites.
- It is the duty of all the girls to report to the Warden, in case they notice any unwanted incidents or undesirable activities going on in the hostel or in the campus.

VISITOR'S ENTRY

- 1 Girls are not allowed to stay in the hostel room with their female relatives or others relatives after 7.00 pm. and should not invite them for visit at night.
- 2 Parents of girls will be allowed to visit inside the hostel, no other relatives will be allowed inside the hostel campus.
- 3 The visit of boys students to the girls hostel is strictly prohibited.
- 4 No hostelite shall permit any outsider in the room.

USE OF APPLIANCES

- 1 Admitted girls will be given one table, one chair in each room.
- 2 The tube light for the first time will be provided by the hotel administration but after that if it breaks down, the girls will have to replace it at their own expenses.

- 3 Girls are allowed to use electric grill for their personal work.
- 4 The use of electrical appliances such as immersion heaters, electric stove, electric irons are forbidden in any of the rooms allotted the residence.
- 5 When the students go out of their rooms they should switched off all the fans and lights.

T.V. ROOM, READING ROOM& RECREATION ROOM

- 1 Girls are allowed to watch T.V. at 8.00 to 10.00 pm. Daily.
- 2 T.V. room will be locked at 10.00 pm.
- 3 Girls are allowed to watch the T.V. extra time on special occasions with the permission of Warden.
- 4 Girls will get extra T.V. watching time on every Sunday.
- 5 Girls can use reading room for their study as well as for reading newspapers, magazines or any good books.
- 6 It is the responsibility of girls to keep the reading room neat and clean, avoid the damages of reading room furniture.
- 7 Girls are allowed to use Recreation room during their free time.
- 8 It is individual and collective responsibility of every girl to take care of the equipments of recreation room.
- 9 Outsiders are not allowed inside the T.V., Reading And Recreation rooms.
- 10 Any hostelites are found responsible for bringing any outsiders inside these rooms, suitable action will be initiated immediately and the same will be informed to their parents.
