The parties having discussed fields of common interests and allied activities between the two organizations, have decided to enter into long-term collaboration for promotion of students' training and skill development in the field of "Thermal Power Plant Engineering"

WHEREAST the "First Party" is MAHAGENCO, the major power generating company In Maharashtra and Western India (committed to expanding the generation capacity to meet the ever-growing power supply need of the state of Maharashtra), AND WHEREAS the "Second Party", established as a college and recognized by University Grants Commission and its Departments are involved in teaching at graduate and post graduate level Science / Computer Science & Application / Information Science (specific areas of research), affiliated to Gondwana University, Gadchiroli.

AND WHEREAS it has been considered expedient to agree in writing to participate jointly in running the short-term Certificate Course on "Thermal Power Plant Engineering" for undergraduate and post graduate students requiring exposure, expertise and logistics from both the parties.

#### Article1. Scope

- 1.1 The second party will recognize the First party as an organization for hands on experience and field visit to the CSTPS Training Centre and areas of Operation & Maintenance of the power station and training of the students enrolled for the short-term Certificate Course on "Thermal Power Plant Engineering" that will help in understanding various operations and processes involved in the Operation & Maintenance of Power Plant.
- 1.2 The Second party has approached the First party to establish an effective relationship in the larger interest of the students as well as the sector.
- 1.3 Working closely with the industry for establishing the curriculum as per its requirements and with academia to enhance the skills of students fostering quality education. Enhancing skills of students/aspirants through internship and vocational training.
- 1.4 The First Party shall have access to the research instrumentation facility available with Second Party like Calibration, Chemical Analysis etc. and library facilities.

Therefore, in consideration of the previous and mutual covenants hereinafter contained, the parties hereto agree to jointly play an effective role in uplifting the industrial Sector and improving environment through skill enhancement of the science/Engineering students through classroom and industry specific practical training ensuring quality towards excellence in science and technology.

# Article2. Objectives

- 2.1 Design, develop and deliver programmes ensuring required quality in Thermal Power Plant Engineering domain which in turn will lead to professional courses as per the industry requirements and making aspirants employable.
- 2.2 Woking closely with industrial sector for establishing the curriculum as per its requirements and with academia to enhance the quality of education in science and industrial sector in the country.
- 2.3 Enhancing skills of students/aspirants through and vocational training.

### Article3. Management

3.1 Competent Authority of the First party and the Head of the institution of the Second party will be responsible to work out operational details of co-operation between the two organizations and ensure proper and effective implementation of this MoU.

### **Article4. Joint Responsibilities**

- **4.1** The Second party shall provide the available infrastructure and basic amenities for running the Course and other activities in conjunction with the First party in the scope.
- 4.2 The Second party shall treat First party as a training partner for joint activities for mutual benefits.
- 4.3 The First party shall make provision for a field visit of enrolled students of Second party to the power station particularly to Operation and Maintenance sites of TPS to meet the objectives of the course.
- **4.4** Guest lectures of expertise personnel's of the First party shall be conducted to benefit the students with their knowledge, skill and experience related to advanced and latest technology used in the plant for water and effluent treatment.

### Article5. Financial Arrangement

**5.1** The certificate course will be fully funded by the Second party itself and there will be no financial obligation on the First party (MAHAGENCO) in the future.

## Articles6. General provisions

- 6.1 It is understood that the First party and the Second party subscribe to the principle of equal opportunity and do not discriminate based on race, sex, age, caste or religion. Both the organizations shall abide by these principles in the administration of this agreement and neither party shall impose criteria for exchange of scholars or students, which violate principles of non-discrimination.
- 6.2 All questions related to this MoU arising during its term will be settled by the parties by mutual agreement. Disagreements at the operating level shall be forwarded to respective higher officials for appropriate resolution.
- 6.3 All question not foreseen related to this MoU will be handled by the parties by mutual agreement.
- 6.4 Nothing in this MoU is intended to affect other cooperation or collaborations between the parties.

## Article7. Admission and Fees

- **7.1** Admission of the students and the award of degrees for different programmes will be the responsibility of the Second party as per the rules and regulations.
- **7.2** Allotment of the students at the First party will be done by the approval of Competent Authority of the First party and Head of the Institution of the Second party.
- 7.3 The First party would have the right to screen the student's eligibility for admission based on their academic period.

# Article8. Entry into effect, modification and termination

- **8.1** This MoU shall become effective on the date it is signed by the parties and shall be valid for three years extendable up to five years. Both parties shall review the status of the MoU at the end of each three/five year period to determine any modification, whenever necessary. The period of validity of this MoU may be extended by mutual consent up to five years. This MoU may be amended by mutual written agreement and may be terminated at any time by either party upon written notification signed by the competent authority of the party initiating termination. Such notification must be given to the other party at least three months in advance from the effective date of termination.
- **8.2** All joint activities not completed at the expiration or termination of the MoU may be continued until their completion under the terms of this MoU.
- 8.3 No amendment or modification of the MoU shall be valid unless the same is made in writing by both the parties or their authorized representatives and specifically stating the same to be amendment of the MoU. The modifications/changes shall become part of the MoU and shall be effective from the date on which they are made/executed, unless otherwise agreed to.


