1.0 Introduction

Sardar Patel Mahavidyalaya was established in 1970 with an aim to provide quality education to students from rural and backward region of Chandrapur district, Maharashtra. The college offers number of basic and professional programmes from undergraduate to research level in Arts, Commerce, Science and other faculties. All the programmes are directed towards realization of our Vision and Mission and achieving our objectives in keeping with the values set by Sarvodaya Shikshan Mandal.

Around 3500 students are enrolled under all courses excluding junior college with 48 university approved faculty members. Among enrolled students 67% students are girls and about 78% students belong to socially and economically backward class. Sarvodaya Shikshan Mandal was awarded with Best Management award by Government of Maharashtra.

Internet leased line is required to serve the students, faculty members, of the College. Tenders are invited for 50 MBPS Internet Leased Line (1:1) Connectivity, Networking, Establishing Server Room, LAN, Secure WIFI to 2000 Students with all Supporting Hardware at the campus of Sardar Patel Mahavidyalaya Chandrapur.

2.0 Eligibility Criteria

The Bidder, fulfilling the following criteria shall be eligible to apply:

- i. The Bidder should provide end to end connectivity (via local loop) on Optical Fibre Cable in Ring Topology.
- ii. Self-attested valid License Copy of Certificate and Infrastructure Details must be enclosed with Technical Bid.
- iii. The list of existing Clients (Educational Institutions / Government Departments / PSUs) who have been supplied Internet/CCTV/NETWORKING/ PUBLIC HOTSPOT in last two years should be provided along with Work Orders and satisfactory Performance Reports. Minimum list of 2 or more Clients to be provided.
- iv. The Bidder would ensure that the local loop provisioning does not violate regulations as laid by Government of India / TRAI in respect of such links/ networks. Bidder will be responsible for making all the payments towards the local loop charges/rentals/WPC Charges etc.
- v. The Bidder must have a fully functional Network Operation Center(s) to monitor and manage the 1Gbps link, which is fully operational 24 X 7 X 365 days. List of NOC(s) must be enclosed with Technical Bid.
- vi. The Bidder must have adequate bandwidth at the backend to provide the desired bandwidth in college. Supporting document must be enclosed with Technical Bid. The Bidder should not have been debarred and / or blacklisted by any Central Government / or any State Government / Autonomous Department(s) / Body as on the last date of submission of the Tender.
- vii. The link provided by the Bidder should be DDOS protected.

3.0 Conditions of Bid

- 3.1 The University reserves the right to reject any or all Bid, wholly or partly or close the bids at any stage prior to the award of contract without assigning any reason

whatsoever.

- 3.2 The College reserves the right to carry out the capability assessment of the Bidders and the Authority of the College decision shall be final in this regard.
- 3.3 The bid of any bidder who has not complied with one or more of the conditions of eligibility criteria and / or fails to submit the required documents as required / or mentioned in tender document is liable to be summarily rejected.
- 3.4 It shall be the responsibility on the Bidder to fully inform /acquaint / familiarize itself with local conditions and factors, which may have any effect on the execution of services to be rendered under the contract. All Bidder (s) intending to bid shall visit, if required and make themselves thoroughly acquainted with the local site conditions.
- 3.5 The University shall presume that the Bidder has understood and agreed that all the relevant factors have been kept in view while submitting the bid. No financial adjustment arising thereof shall be permitted by college, on the basis of any non-clarity of information about local conditions being pleaded by the bidder.
- 3.6 The Service Provider shall responsible for providing the 100 MBPS Internet Leased Line (1:1) Connectivity, Networking, Establishing Server Room, LAN, Secure WIFI to 2000 Students with all Supporting Hardware at the College at all times throughout the Contract Period.
- 3.7 The Bidder shall be responsible for installation, commissioning and configuring of hardware for connectivity providing, configuring and provisioning a suitable edge router. The Bidder will maintain the OFC and equipment to provide Internet Services to the College Server Room for efficient running at all times of the contract.
- 3.8 Liasioning, if required with outside Agency/Government Authority for obtaining point to point connectivity between Service Provider Node and College, shall be the sole responsibility of the Service Provider/Bidder.
- 3.9 The Service Provider would ensure that the local loop provisioning does not violate any regulations as laid by Government of India / TRAI in respect of such links / networks. Service Provider shall responsible for making all the payments towards the local loop charges / rentals / WPC charges etc.
- 3.10 The Service Provider will do preventive maintenance once a quarter for upkeep of the systems running. The schedule will have to be adhered to strictly.
- 3.11 The College will not procure any hardware and the Service Provider will have to provide all the required hardware or latest technology from time to time and will also be fully responsible for its maintenance.

4.0 Support & Services during Contract Period:

- 4.1 The Service Provider should provide support desk details with escalation matrix for handling of support related services during the contract period.
- 4.2 The University shall be able to directly log any issue with Service Provider and interact with support personnel for resolution of any issue, obtaining technical guidance for any further changes in the software or its configuration, upgrades, updates and all other types of technical queries.
- 4.3 Service Provider shall provide periodic reports pertaining to utilization of resources.
- 4.4 Service Provider shall provide access to log files to the College.
- 4.5 Service Provider shall inform the College at least 1 week in advance for any planned system downtime.
- 4.6 Service Provider shall inform the College immediately in case of any unplanned downtime, and cyber incidents.
- 4.7 In case of change of service location, reconfiguration of solution shall be done at no extra cost.

5.0 Bid Price:

- 5.1 The work shall be as described in **Annexure 1**.
- 5.2 GST, if applicable, shall be paid by the bidder as per prevailing rates.
- 5.3 The Rate quoted by the Bidder shall be in “Indian Rupees”
- 5.4 The College and its officers/employees will not be responsible to any liabilities, entitlement or claims in the context of any statutory dues, charges, demands etc. of whatsoever for undertaking the said Contract by the Service Provider.
- 5.5 During the Contract Period, any damages / loss caused to the College will be recovered the selected Service Provider.
- 5.6 **Single Bid by Individual Bidder:** Each Bidder shall submit only one bid.
- 5.7 **Validity of Bid:** Tender shall remain valid for a period of not less than 90 days after the deadline date specified for submission.

6.0 Evaluation of Bids:

The College will evaluate and compare the bids determined to be substantially responsive

i.e. which:

- 6.1 Are properly signed on each page and submitted in proper format; and

6.3 Conditional Tender(s) will not be accepted.

6.4 The evaluation of the proposals shall be done in two stages: Technical Bid Evaluation and Financial Price/Bid Evaluation.
